#### AMENDMENT TO RESERVATIONS AND RESTRICTIONS FILED of woodlake subdivision, section one

WHEREAS, Wellborn Development Corporation caused Correction Reservations and Restrictions of Woodlake Subdivision, Section One, to be recorded in Volume 411, page 868, of the Deed Records of Brazos County, Texas; and

WHEREAS, with respect to amendments to the Correction Reservations and Restrictions of Woodlake Subdivision, Section One, those Reservations and Restrictions state:

"The term of the Restrictions shall be for a period from the filing of this instrument for record in Brazos County, Texas, until the 1st day of January, A.D. 1991, after which date such Restrictions shall be automatically extended for successive periods of ten (10) years each, unless and until, by instruments executed by the then record owners of a majority of the parcels in Woodlake and duly recorded in Deed Records of Brazos County, Texas, such Restrictions are altered, rescinded, modified or changed, in whole or in part";

and

WHEREAS, the record owners of parcels of the subdivision desire to amend the Restrictions;

IT IS. THEREFORE, AGREED that:

- (1) The amendments to the Reservations and Restrictions of Woodlake Subdivision, Section One, are attached hereto as "EXHIBIT A".
- (2) A list of the record owners of parcels in Woodlake Subdivision, Section One, as of October 19, 1993 is attached hereto as "EXHIBIT B".
- (3) Those record owners of parcels in Woodlake Subdivision, Section One who agree to the amendments in the Reservations and Restrictions have signed "EXHIBIT C" attached hereto and made a part hereof for all purposes. In accordance with the requirements for amending the Reservations and Restrictions, these records owners own a majority of the parcels in Woodlake Subdivision, Section One.

#### Insert After General Restrictions

#### SECTION ONE WOODLAKE ESTATES HOMEOWNERS' ASSOCIATION

The Section One Woodlake Estates Homeowners' Association, a Texas nonprofit corporation, shall be incorporated with its initial registered office in Wellborn, Brazos County, Texas, and with its principal office located at 16350 Woodlake Drive, College Station, Texas 77845. As used hereinafter, "Association" shall mean the Section One Woodlake Estates Homeowners' Association, its successors and assigns, and where appropriate, the Board of Directors thereof. The Association shall have the powers and functions provided by applicable law, its Articles of Incorporation, its By-Laws, as heretofore or hereafter amended, respectively, and such other powers as set forth herein. The Association shall administer the Maintenance Fund hereinafter mentioned as provided within the Restrictions.

Lot ownership and membership in the Association shall be inseparable. Transfer of a Lot automatically transfers membership in the Association. Execution of a contract of sale shall constitute transfer of a Lot for purposes of Association membership. Termination of a Contract of Sale shall cause the membership to revert to the record owner. Voting rights in the Association shall be as specified in the By-Laws of the Association.

#### Replace Architectural Control, 2d Paragraph, 4th Sentence

Effective as of the date of this Amendment, the power to designate members of the Architectural Control Committee will automatically pass to the Association.

#### Insert after Architectural Control

DUES

Each property owner in Section One, Woodlake Estates is hereby subject to annual dues as established in the By-Laws of the Association, payable in advance on the 15th day of January of each year, beginning January 15, 1994, and each succeeding year thereafter to the Association, its successors and assigns, for the purpose of creating a fund described below, known as the "Maintenance Fund". Failure to pay dues results in termination of voting rights in the Association until all delinquent dues are paid.

#### MAINTENANCE FUND

The dues shall be used to pay "maintenance expenses" which in the opinion of the Association would benefit the subdivision as a whole and for payment of

legal and other expenses in connection with the operation of the Association, and the enforcement of all recorded charges, restrictions, covenants, agreements and conditions affecting property to which dues apply, and doing any other things necessary and desirable in the opinion of the Association to keep property neat and in good order of which it considers of general benefit to the subdivision. The act of the Association and its expenditures of the Maintenance Fund shall be final so long as it acts in good faith.

1. The foregoing Restrictions are adopted as part of and shall apply to each and every parcel in Woodlake. Such Restrictions are equally for the benefit of Wellborn, its successors and assigns, and for the benefit of all subsequent owners of parcels in Woodlake and accordingly, shall be covenants running with the land. Any owner or lienholder of any property <u>and the</u> <u>Homeowners' Association</u> shall have the power to prosecute in the appropriate court a suit at law or in equity to prevent any violation or attempted violation of the Restrictions and to recover damages for any violation or attempted violation including, but not limited to, reasonable attorney's fees; provided, however, that this clause shall not restrict any governmental agency from acting to enforce any of the Restrictions.
