### Minutes of the WPA Board meeting held on August 12, 2024

### Larry Dooley called the meeting to order at 7:04 PM

#### **Board Members Present**

#### **Presentation of Minutes**

Charley Todd reviewed the minutes from May 20, 2024. Robert Patterson made a
motion to accept the minutes. Linda Huff seconded the motion. All present voted in
favor of the motion.

### **Treasurers Report**

- Linda Huff presented the Financial Report.
- Dan Mizer made a motion to accept the Treasurer's Report. Charley Todd seconded the motion. All present voted in favor of the motion.

# **Lake Report**

- Dan Mizer Presented the Lake Report.
- There were two weed treatments in May. Lake treatments are currently targeting
  Alligator Weed and Smart Weed, although other species are also controlled. There
  was an algae treatment made on June 25. Dan reported that we are currently in
  decent shape regarding weed control.
- Dan Mizer raised the issue of watering new grass in the Primary Emergency Spillway
  area once the repairs are complete. The estimated cost is \$200.00 per truck, with at
  least three waterings required. Dan made a motion to commit up to \$1500, as
  needed for watering to ensure grass survival. Charley Todd seconded the motion.
  The motion passed unanimously.
- Samples taken in May revealed that the samples taken of the sedimentation in Calumet Cove, and Riva Ridge cove were mostly silt and clay. The earlier proposal of an enzyme treatment will not be effective because the sedimentation is mostly not organic.

- The shredding machine used on the dam had a bad tire. After the contractor replaced the tire, he completed the shredding with an even result.
- The fence repair adjacent to the Commons entrance will not be done until the dozer work by Charlie Eubanks is complete. The entrance created by the partial collapse of the fence will allow the heavy equipment to enter. Southern Lawns and Shredding will then install the fence.
- Linda Huff made a motion to accept the Lake Report. Robert Patterson seconded. All present voted in favor of the motion.

## **Architectural Report**

  Prior to the Architectural Control Committee review, the Treasurer confirms that the
  requestor is current on annual dues. The submission is also reviewed to ensure that
  all required documentation for the request is included with the submission.
